This will be a one-day tournament with a 5-game qualifying round and stepladder final. **Div. 1 will be scratch with Divs. 2-3&4 Handicap.** At the discretion of the tournament committee, if a division has less than 10 entrants, the 4 divisions may be adjusted to 3.

In each division approximate payout will be 1 in 3. All prize money is paid out 100%. Total prize money will be based on number of entries. Additional prize money is available this year due to sponsorships and fundraisers.

Door prizes, raffles, and bowling merchandise will be available.

***Be sure to include your phone number on the entry form.*** You may also indicate on the entry form with whom you would like to bowl with in the qualifying round.

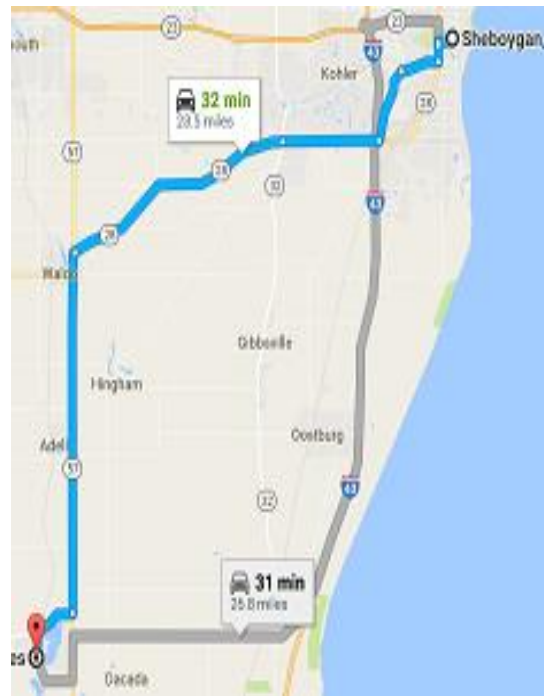

### **Tournament Rules**

1. Contestant must be a member of the Sheboygan USBC Women's Bowling Association. Bowlers who are not members of a league may purchase an associate membership for \$15.00 prior to bowling.
2. Bowlers must use their highest sanctioned league average from the previous season. If no average from the previous season, use the highest average from the current season as of November 10<sup>th</sup>, 2015 if 21 games have been bowled. If no average, bowlers must enter Division 1. USBC 10-pin rule 319a-2 does not apply. Rule 319a-3 (disqualification for submitting a false average) will be in effect. Rules 319d and 319e are waived for this tournament. Averages may be adjusted the day of the tournament.
3. **New Format: Division 1 Scratch with Divisions 2, 3 and 4 Handicap.**
4. There will be a 10-minute warm-up before the qualifying round.
5. Qualifying round will consist of 5 games across 10 lanes. After the final qualifying round, each division will be cut to the top 5 for the stepladder final.
6. All pinfall from the qualifying round will be dropped and bowlers will start the final round from zero. Any ties for the five qualifying places will bowl a three frame roll-off to determine placement.
7. The final round will be a stepladder format, qualifier 5 bowls 4, winner bowls 3, winner bowls 2, and winner bowls 1 until a champion is determined.
8. In the event of a tie for any position during the final round, a 3-frame roll-off will be bowled to determine the winner.
9. If a bowler is unable to start or complete any portion of the final round, the last bowler to be eliminated (who is still present) will be given the opportunity to replace her in the finals. This will include the alternate (6<sup>th</sup> place qualifier).
10. There is no dress code for the tournament, but please use discretion.
11. If a bowler cancels or is injured before qualifying, a refund of the lineage will be returned. The Prize Fund is not refundable. If a bowler cancels before the closing of entries on Tuesday, November 10<sup>th</sup> 2015, a full refund will be returned.
12. The tournament committee will address any issues not covered by these rules.
