WINNER OF THE MATCH WILL RECEIVE 30 BONUS PINS. AFTER ROUND ROBIN MATCH PLAY IS OVER, THERE WILL BE 1 GAME OF POSITION ROUND, WITH THE WINNER OF THE POSITION ROUND MATCH RECEIVING 30 BONUS PINS. THE TOURNAMENT WINNER WILL BE DETERMINED WITH THE HIGHEST AMOUNT OF PINS FROM QUALIFYING, MATCH PLAY, POSITION ROUND, AND BONUS PINS COMBINED

TOURNAMENT RULES

1. ELIGIBILITY:

ALL CONTESTANTS MUST BE A CURRENT USBC MEMBER AND A SBA MEMBER WITH ONE OF THE FOLLOWING: A MINIMUM OF 12 GAMES BOWLED IN CURRENT SEASON OR HAVE AN SBA AVERAGE IN AT LEAST 5 PRIOR YEARS. NO ONSITE SANCTIONING WILL BE ALLOWED.

2. TOURNAMENT SITE:

SATURDAY, DECEMBER 16TH AT JB'S ENTERTAINMENT CENTER IN HOWARDS GROVE, WI.

CHECK IN IS FROM 9:00 A.M. – 9:30 A.M.

PRACTICE IS FROM 9:40 A.M. – 9:55 AM ON ANY OF THE QUALIFYING LANES START TIME = 10 A.M.

3. DEADLINE:

FRIDAY DECEMBER 15TH, 2017 AT 12:00 A.M. THE SBA WILL ACCESS A \$5.00 LATE FEE FOR ALL ENTRIES RECEIVED AFTER DEADLINE.

4. ENTRY FEE:

\$60.00 PER PERSON. (\$20.00 BOWLING, \$1.00 EXPENSES, \$39.00 PRIZE FUND)

5. TOURNAMENT FORMAT:

ENTRANTS WILL BOWL 5 GAMES OF QUALIFYING (**ON A KEGEL OIL PATTERN THAT WILL BE POSTED AT THE TIME OF CHECK IN.**) MOVING AFTER EVERY GAME. 1 IN 4 WILL CASH WITH THE TOP 6 MOVING ON TO ROUND ROBIN MATCH PLAY (**NO REOIL**), WINNER OF EACH MATCH WILL RECEIVE 30 BONUS PINS. AFTER MATCH PLAY IS COMPLETED, THERE WILL BE A 1 GAME POSITION ROUND WITH THE WINNER OF THE POSITION ROUND MATCH RECEIVING 30 BONUS PINS. THE TOURNAMENT WINNER WILL BE DETERMINED ON WHO HAS THE HIGHEST PIN TOTAL FROM QUALIFYING, MATCH PLAY, POSITION ROUND, AND BONUS PINS COMBINED.

6. IN THE EVENT OF A TIE:

A ONE-GAME ROLL-OFF WILL BE HELD TO BREAK A TIE TO DETERMINE A TOURNAMENT CHAMPION OR A LAST CASHERS SPOT. IF A TIE STILL EXISTS, A 9TH AND 10TH FRAME ROLL WILL BE HELD. IF ANOTHER TIE OCCURS, 9TH AND 10TH FRAME ROLL OFFS WILL CONTINUE UNTIL A WINNER IS DETERMINED. ALL OTHER TIES WILL BE BROKEN BY THE LOWEST QUALIFYING GAME AS THE LOWER SEED OR CASHING SPOT.

7. PRIZE LIST:

PRIZE PAYOUT IS 1 IN 4 AND ALL PRIZE MONEY WILL BE RETURNED 100%.

8. TOURNAMENT DIRECTOR:

ANY RULE INFRACTIONS OR DISPUTES MUST BE BROUGHT TO THE ATTENTION OF A TOURNAMENT DIRECTOR. EVERY EFFORT WILL BE MADE TO MAKE DECISIONS THAT ARE FAIR FOR ALL PARTIES INVOLVED. **ALL DECISIONS MADE THEREAFTER ARE FINAL UNLESS A APPEAL IS MADE IN ACCORDANCE TO USBC RULE 329.**

9. MISCELLANEOUS RULES:

ANY BOWLER WHO SHOWS UP LATE WILL RECEIVE ZERO (0) FOR EACH FRAME COMPLETED BY BOWLERS ON THAT PAIR OF LANES.

THERE WILL BE **NO REOIL** BETWEEN QUALIFYING AND MATCH PLAY.

IT IS YOUR RESPONSIBILITY TO TURN IN SCORE SHEET INTO TOURNAMENT TO TOURNAMENT DESK AFTER QUALIFYING AND MATCH PLAY ROUNDS.
