TOURNAMENT RULES

1. ELIGIBILITY:

ALL CONTESTANTS MUST BE A CURRENT USBC MEMBER AND A SBA MEMBER WITH ONE OF THE FOLLOWING: A MINIMUM OF 12 GAMES BOWLED IN CURRENT SEASON OR HAVE AN SBA AVERAGE IN AT LEAST 5 PRIOR YEARS. NO ONSITE SANCTIONING WILL BE ALLOWED. MUST BE 50 YEARS OLD BY JANUARY 11TH 2017 TO COMPETE.

2. TOURNAMENT SITE:

SUNDAY, FEBRUARY 25th 2018 , JB's ENTERTAINMENT CENTER, HOWARDS GROVE, CHECK IN IS FROM 9:00 A.M. – 9:30 A.M.

PRACTICE IS FROM 9:40 A.M. – 9:55 A.M. ON ANY OF THE QUALIFYING LANES

3. DEADLINE:

FRIDAY FEBRUARY 23rd, 2018 AT 12:00 am. THE SBA WILL ACCEPT ENTRIES UNTIL 9:30 am THE DAY OF THE TOURNAMENT BUT A \$5.00 LATE FEE WILL BE ASSESSED

4. ENTRY FEE:

\$40.00 PER PERSON. (\$15.00 BOWLING, \$1.00 EXPENSES, \$24.00 PRIZE FUND)

5. TOURNAMENT FORMAT:

ENTRANTS WILL BOWL 5 GAMES OF QUALIFYING **ON THE HOUSE LEAGUE CONDITION**, MOVING AFTER EVERY GAME. BOWLERS WILL ONLY BOWL AGAINST OTHER BOWLERS WITHIN THE AGE GROUP. 1 IN 4 WILL CASH WITH THE MINIMUM OF THE TOP 3 BOWLING A STEP LADDER FINALS IN THE AGE GROUPS OF 50-59 AND 60-69. MORE BOWLERS WILL MAKE STEP LADDER FINALS DEPENDING ON THE AMOUNT OF BOWLERS ENTERED IN THEIR AGE GROUP. IN THE AGE GROUP OF 70 +, THE CHAMPION WILL BE DETERMINED BY WHICH BOWLER HAS THE HIGHEST PIN FALL FROM QUALIFYING

(NO STEP LADDER FOR THE 70 + AGE GROUP)

6. IN THE EVENT OF A TIE:

IN THE EVENT OF A TIE FOR THE LAST CASHING SPOT OR IN THE STEP LADDER FINALS. A 9TH AND 10TH FRAME ROLL OFF WILL OCCUR TO BREAK THE TIE. IF A TIE HAPPENS AGAIN, A 9TH AND 10TH FRAME ROLL OFF WILL CONTINUE UNTIL THE TIE IS BROKEN. IN THE EVENT OF A TIE FOR SEEDING INTO THE STEP LADDER FINALS, THE PLAYER WITH THE LOWEST QUALIFYING GAME WILL BE THE LOWER SEED.

7. PRIZE LIST:

PRIZE PAYOUT IS 1 IN 4 AND ALL PRIZE MONEY WILL BE RETURNED 100%.

8. TOURNAMENT DIRECTOR:

ANY RULE INFRACTIONS OR DISPUTES MUST BE BROUGHT TO THE ATTENTION OF A TOURNAMENT DIRECTOR. EVERY EFFORT WILL BE MADE TO MAKE DECISIONS THAT ARE FAIR FOR ALL PARTIES INVOLVED. **ALL DECISIONS MADE THEREAFTER ARE FINAL UNLESS AN APPEAL IS MADE IN ACCORDANCE TO USBC RULE 329.**

9. MISCELLANEOUS RULES:

ANY BOWLER WHO SHOWS UP LATE WILL RECEIVE ZERO (0) FOR EACH FRAME COMPLETED BY BOWLERS ON THAT PAIR OF LANES.

THERE WILL BE **NO REOIL** BETWEEN QUALIFYING AND STEP LADDER FINALS.

IT IS YOUR RESPONSIBILITY TO TURN IN SCORE SHEET INTO TOURNAMENT TOURNAMENT DESK AFTER QUALIFYING AND STEP LADDER FINALS.
