**209 and under = HANDICAP 100%**

**210 and over =SCRATCH**

**\$500.00 First Place in Each Division (Based on 96 entries per division) 1:4 WILL CASH 100% of Prize Fund will be paid out**

**FORMAT: 4 Games of qualifying across 8 lanes**

**TOP (8) bowlers in each division will bowl a 2 game Combined total Bracket elimination**

**\$ 25.00 will be paid for the high game in each Division**

**DATE: Qualifying: SATURDAY, Jan. 6, 2018 (11:00 am) FINALS to begin immediately following the completion of Qualifying**

**ENTRIES CLOSE: All Entries must be received by Midnight Thurs. January 4th 2018.**

**ANY ENTERIES RECEIVED AFTER THAT WILL BE ASSESSED A \$10.00 LATE FEE.**

**THE FIRST 144 ENTRIES RECEIVED WILL BE ACCEPTED.**

**Rules**

**1) Tournament will be awarded to a center in 1 of the 3 counties (Sheboygan, Fond du Lac, and Ozaukee) to be rotated yearly on a round- robin basis.**

**2) All participants must be a current USBC member in the Sheboygan, Fond du Lac, or Ozaukee Bowling Associations**

**3) Averages will be based on highest 2016-2017 book average in that bowlers association. If no average for that year, then previous year's book average may be used. If no average from the previous 2 years, bowlers will be allowed to use this year's highest average provided 21 games have been bowled. If none of the above applies, then bowlers shall compete in the 210+ scratch divisions. The 15- pin rule will be in effect.**

**4) Entries will be \$45 provided that the entry is received 2 days before the start of the Tournament on Jan.6, 2018 Entries received after January 4th , 2018, will be assessed a \$10.00 late fee. Only the first 144 entries will be accepted**

**5) All bowlers will bowl (4) four games of qualifying across (8) lanes. Total pins after the 4 games will determine the seeding for the top (8) bowlers in each average division for the bracket finals. In the event of a tie for a position of 1-7 a coin flip will determine that player's position. A tie for 8th place, will result in a (1) game roll-off Finals will consist of a 2 game combined total single elimination. (I.e. #1 seed vs. #8 seed, #2 vs. #7 etc.)**

**6) No practice bowling will be allowed once the lanes have been conditioned.**

**7) Any rules not mentioned above will fall under the USBC Rule book. 8) The Tournament Committee and Tournament Chairperson will handle all disputes**
